At the Faculty of Social Sciences, Department of Political Science, a PhD Scholarship on investment in childcare and human capital formation in China and the EU is open for appointment on 1 November 2015 or as soon as possible.

Job description

Centre for Comparative Welfare Studies (www.CCWS.dk) announces a PhD scholarship in cooperation with the Sino-Danish Center for Education and Research (www.sinodanishcenter.dk). The PhD project should focus on investment in childcare and the formation of human capital and apply a comparative perspective that both include Western countries and China. In Western countries, especially within the European Union, there has been a renewed focus on the importance of investment in childcare services. Thus, to a larger and larger extent it is emphasized that pre-school is crucial for human capital formation. Therefore the pre-school phase is also crucial for establishing equal life chances across gender, classes and ethnic groups. In a Western context, the Nordic countries have been frontrunners in this effort to establish high quality childcare facilities. Through tax-financed services such as health visitors, GPs and public kindergartens this area has be institutionalized. And the services have been supported by a decentralized administration within municipalities and a national educational system that has established various childcare professions. The Chinese childcare facilities are still in the making. The PhD project should contribute to the international literature on how to organize and implement public investment in childcare. Added value will be a comparative perspective that both include economic developed and less developed societies. The Chinese context provides an excellent opportunity to study the effect from childcare investment, e.g. through evaluations of new Chinese initiatives or even randomized experiments. And the Nordic context, with more than three decades of experience, provides an excellent opportunity to study how these childcare services can be effectively administrated and implemented; knowledge that could be of crucial importance for the Chinese development.

The PhD student will be enrolled at the Centre for Comparative Welfare Studies (www.ccws.dk), which is a leading Danish center for welfare state studies. The PhD project will be supervised by staff from CCWS and cosupervised by Professor Linxiu Zhang, which is a leading Chinese expert in the field. In the three year period, the PhD student will be located (minimum) 12 month in Beijing, hosted by professor Linxiu Zhang at the Center for Chinese Agricultural Policy (http://www.ccap.org.cn/), and at Aalborg University (minimum 12 months). The travel and accommodation costs will be covered. In terms of teaching, the PhD student will contribute to a course taught to a mix of Danish and Chinese students in the program "Public management and social innovation" at the Sino Danish Center in Beijing. The Faculty of Social Sciences wishes to ensure that PhD scholarships provide career opportunities both within and outside of the university. For that reason, PhD scholarships are formed in a manner ensuring that the competencies achieved in the position qualifies to both a career within research and a career in the private and/or public sector. No later than one year before the termination of the position, you are offered an interview in order to clarify your further career.

Qualification requirements:

The PhD scholarship has a duration of three years. Applicants to the PhD scholarship must hold a degree equivalent to a Danish Master's degree. Applicants enrolled at a Danish Master programme who expect to graduate before the date of appointment must forward a copy of their thesis contract and documentation for the date of their final exam.

The completion of the scholarship will be in accordance with the <u>Ministerial Order</u> on the PhD Programme at the Universities No 1039 of 27 August 2013, and it is a prerequisite for allocation of a scholarship that enrolment as a PhD student at the <u>Doctoral School of Social Sciences</u> takes place.

- project proposal (approx. 5 pages) containing the research project title, an outline of the course of study and a description of the overall problem areas
- information on which language the PhD thesis is expected to be written in
- · curriculum vitae
- diplomas confirming academic degrees (Master degree), including academic transcripts
- foreign applicants must forward verified IELTS test (International English Language Testing System). Exempted
 are applicants with at Master Degree from Denmark, United Kingdom, Ireland, South Africa, Australia and
 Canada
- Co-author statement. If publications that have been written in cooperation with others are submitted, a declaration from each of the authors must be enclosed. The declaration must state the extent of the applicant's contribution to the total work and be signed by the authors.
- Application for credit transfer if relevant.
- The complete application including attachments shall be sent electronically by selecting the "apply online" function.

Assessment

The assessment of the applicants will be undertaken by an expert assessment committee.








Sino-Nordic Conference in Beijing, 20-21 June 2015

The Sino-Nordic Welfare Laboratory, which is being established at the Institute of Sociology, Chinese Academy of Social Sciences, Beijing, organized jointly with SNoW an international seminar on **«Ageing Welfare & Social Policy»** at CASS, Beijing, 20 -21 June 2015. Altogether 25 papers were presented. Most participants came from China, from 8 different universities/research institutions, plus Hong Kong, and other participants came from Denmark, Finland, Norway, Sweden, Australia, South Korea, and the USA. The plan is to edit papers for a book publication.

NordWel International Summer School 2015

The NordWel (http://blogs.helsinki.fi/nord-wel/) PhD Summer School 2015 took place at the University of Helsinki, Swedish School of Social Science, during 9-12 June 2015.

The summer school was organized in collaboration with, and co-financed by, SNoW.

The program consisted of lectures, workshops and panel discussion. The lectures were held by international and Nordic senior scholars and addressed different central themes and topics in welfare research. Altogether 16 PhD candidates from Nordic and Chinese universities attended the course. They all presented papers which were discussed and commented upon by seniors scholars and fellow PhD candidates. in workshops, one hour per paper.
